

How to Access the Training Courses in USAV Academy

The easiest way to access the training in USAV Academy, is through WebPoint (the same system that you registered for the training).

1. If you are not logged in to WebPoint...
 - a. Access WebPoint at <https://webpoint.usavolleyball.org/>
